Theft from Motor Vehicles: Yes, it's happening again. Several incidents have been reported and almost always it's the same old story-unlocked doors, good stuff in plain view etc. etc. What can be done besides asking people to take precautions? I'm open to ideas. I've asked the captain to loan us a uniformed officer and walk the streets testing for unlocked doors but he fears this might be an invasion of privacy in the absence of a warrant-so no-go on that. Here are two new considerations that we haven't seen yet but be aware of:

- 1. Snatch thefts: Occurs at stop lights in crowded areas or congested locations. Somebody rips the phone or device out of your hand and runs away or rides a bike. Instances have been reported nationwide of purses being snatched out of cars too.
- 2. Window smashing: The opportunity to steal five bucks of loose change causes a thief to break out your window from your locked car and that costs you some serious change.

### **History Corner:**

**November 8, 1942** - Operation Torch, the <u>Allied landings</u> in North Africa, began as 400,000 soldiers under the command of General Dwight D. Eisenhower landed at Morocco and Algeria Note: Many of them came from the base at Little Creek

**November 9, 1989** - The Berlin Wall was opened up after standing for 28 years as a symbol of the Cold War. The 27.9 mile wall had been constructed in 1961.

November 10, 1775 - The U.S. Marine Corps was established as part of the U.S. Navy. It became a separate unit on July 11, 1789

November 11th - Celebrated in the U.S. as Veterans Day (formerly called Armistice Day) with parades and military memorial ceremonies.

November 15, 1777 - The <u>Articles of Confederation</u> were adopted by Continental Congress.

November 19, 1863 - President <u>Abraham Lincoln</u> delivered the <u>Gettysburg</u>

<u>Address</u> during ceremonies dedicating 17 acres of the Gettysburg Battlefield as a National Cemetery.

November 20, 1962 - The Cuban Missile Crisis concluded as President John F. Kennedy announced he had lifted the U.S. Naval blockade of Cuba

November 26, 1789 - The first American holiday occurred, proclaimed by President George Washington to be Thanksgiving Day

**November 30, 1782** - A provisional peace treaty was signed between Great Britain and the United States heralding the end of <u>America's War of Independence</u>

VB Home Now is accepting proposals from organizations that assist families and individuals experiencing homelessness or a housing crisis in Virginia Beach. Specifically, the foundation is seeking innovative projects that contribute to the Virginia Beach homeless service system and will prioritize funding requests that provide resources, create partnerships, and address gaps within our community that directly impact the homeless and at-risk populations.

### COVID-19 Real Estate and Personal Property Tax Relief Program Application Deadline Extended to Nov. 30

The Department of Human Services will continue to accept applications for the COVID-19 Real Estate and Personal Property Tax Relief Program through Nov. 30. The relief program, which was established by City Council earlier this year, aims to provide direct assistance to households where an occupant has been financially impacted through loss of employment, reduction in work hours, or has been furloughed because of COVID-19. A check for the eligible relief amount will be mailed to approved applicants.

A maximum relief of \$500 for residential real estate taxes and \$250 for personal property tax has been established for eligible households. The amount of relief will be the billed total, or the benefit maximum, whichever is lower. Each household could potentially receive both benefits for a maximum relief amount of \$750.
