Skate and Dog Parks:

Virginia Beach Parks & Recreation is doing away with fees for use of its three dog parks and three skate park facilities. Between Feb. 1 and March 31, new users will be charged a nominal one-time prorated fee. Existing customers whose passes expire before March 31 will have their passes extended as a courtesy at no additional charge.

This move is designed to increase public access to parks and programs, improve

customer service and increase efficiencies. There will be less of a burden on the users to complete a cumbersome process and drive to off-site locations to complete transactions.

"We want people to take advantage of our city's incredible outdoor recreation amenities and make it as easy as possible for them to do that. And with more dog parks planned in the near future, access should continue to improve and be easier than ever before," said Parks & Recreation Director Michael Kirschman.

The City of Virginia Beach Finance Department is proud to present the Popular Annual Financial Report (PAFR) for the fiscal year ended June 30, 2018. This is a short form report that provides summarized information about the City's financial activities. It is intended to give readers an overview of the City and its finances. The PAFR provides a

picture of the City's general financial condition, including a brief analysis of where the City's revenues come from and where those dollars are spent.

The Comprehensive Annual Financial Report (CAFR) contains audited financial statements reporting the City's financial position and results of operations. The CAFR is presented in three main sections. The Introductory Section includes a listing of key officials for the City and School Board, an organizational chart and a transmittal letter with a discussion of the City's economy and organizational information. The Financial Section includes the auditor's report, management discussion and analysis, audited basic financial statements and notes to the financials, required supplemental information, combining individual fund financial statements and supporting schedules. The Statistical Section sets forth selected unaudited economic, financial trend and demographic information on a multi-year basis.

Community Organization Grants: Due March 29th

The Community Organization Grant (COG) program provides an opportunity for qualified nonprofit organizations that deliver services to Virginia Beach citizens to receive funding from the City.

The City Council appointed COG Review and Allocation Committee evaluates applications and determines how best to allocate funds among the organizations. Financial and service delivery reports are submitted by recipient organizations as a condition of grant awards. Word versions of these documents are available upon request to Kaitlyn E. All applications are due no later than March 29, 2019 by 5:00 pm.

Regional Organization Grants for Fiscal Year 2019-20

The Regional Organization Grant program provides an opportunity for qualified non-profit regional organizations to receive funding from the City. The specific grant allocations are based on the availability of funds as determined through the annual

operating budget process. A financial report is submitted by recipient organizations as a condition of grant award.

SEA LEVEL RISE EXECUTIVE SUMMARY

"The City of Virginia Beach, VA has recognized that flood impacts are increasing and must not be left unchecked. In addition to sea levels rising at a rate nearly twice that of the global average, Virginia Beach is threatened by changing precipitation patterns and increasingly recurrent tidal, storm surge, and inland flooding events. In order to tackle such challenges, the City must pivot to fully informed planning, infrastructure design, and community engagement."
