Farm Fresh Development: I met with the builder, Justin Boyd of Boyd Homes the other day. He has agreed to come to our February General meeting (not yet scheduled) to discuss the development plans for this project. I've seen the basic renderings and here are a few points:

- 1. Two apartment complexes containing 205 1-bedroom units and 140 2-bedroom units, situated near where the Wells Fargo ATM/Wesleyan Road side is currently
- 2. These two complexes will be five and four stories high and look like the Nexus development on Newtown Road. Boyd did Nexus too. About 600-800 square feet. There will be a central courtyard and rooftop amenities.
- 3. There will be 22 townhomes located near the old Farm Fresh market. Each will have a garage.
- 4. All units will be rentals; Boyd will be the landlord.
- 5. The Sunoco station, the Strickland Oil change facility and the main Sentara outbuilding stay.
- 6. There will be a mixed commercial/office area on the east side-near the Surfrider side
- 7. They are working with the Sentara rehab unit to stay and move to the Surfrider area.
- 8. No bars or nightclubs.
- 9. All rentals will be at market rate
- 10. Less asphalt than currently there; more trees.
- 11. Construction to probably start in late 2027.

<u>Code Enforcement:</u> I'm working with Code Enforcement on the fence line up on Wesleyan and Cypress Point Blvd. as well as the wreckage at the entrance. Please be advised that although the city can enforce certain basic aspects they can't mandate "pretty".



SCAM Alert: Common Facebook Messenger Scams

Facebook messenger scams often seem real and are very convincing. Here are examples of some of the common variants of this scam.

Lottery Scams With a lottery scam, the scammer pretends to either be someone you know or to represent an organization. They tell you you're among a group of people who have won a lottery. However, you can only claim your winnings if you pay a <u>small fee</u>. In some cases, they may also ask for your bank account information or your address. Romance Scams The first objective of a <u>romance scam</u> is to get you to trust the scammer and develop intimate feelings for them. They then use that as leverage to ask you for money or pay for something like a trip or visa. To gain your sympathy, they may pretend to be trying to get out of a bad relationship or claim to have recently been divorced or widowed.

Donation Scams With a donation scam, the attacker pretends to represent a <u>charity</u> or a famous religious person. They are taking advantage of the fact that charities and prominent religious personalities often ask for donations. However, when you donate, the money goes to the scammer.

Government Grant Scams A government grant scam starts with someone reaching out claiming you are eligible for a government grant. They then tell you there is an upfront fee required to receive the funding. To collect the fee from you, they may ask for your bank account information. They may also say you can pay the fee with a gift card, money transfer, cryptocurrency, or a card that allows you to load cash onto it.

Contest Scams A contest scammer uses Facebook Messenger to advertise a contest, but you have to submit personal or contact information to join the competition. They may say you automatically win a prize, such as a gift card, just for entering and may win more later. However, they want to collect your information to either sell or use it to impersonate you online.

Coupon Scams A coupon scam is a type of phishing scam that seeks to get your Facebook login information. The scammer reaches out over Facebook Messenger and says you can take advantage of a coupon from a major retailer or get a vacation at a significant discount. All you have to do is enter your Facebook login credentials on their site. The scammer will then take your information and use it to hack into your Facebook account.

Inheritance Scams An <u>inheritance scam</u> is also often a <u>phishing scam</u> in which the attacker tries to get information from you. They may claim to be an attorney who represents the estate of someone who died and that you're entitled to a portion of the money. They then ask for your bank details or address to either sell them or use them to steal from you.

The "Give Money, and You'll Get More in Return" Scam With this scam using Facebook Messenger, someone claiming to be a friend reaches out and tells you they sent money to someone and got more back in return. They then suggest you do the same. However, when you send your money, you don't get anything sent in return.



In the Garden:

If you have fruit trees, bushes, shrubs, or roses, now's the time to <u>cut off dead branches</u> and trim for shape. It's easier to see what and where to prune in the winter, when there's less foliage. See 10 Easy Pieces: Garden Pruners for some of our favorite pruning tools. Got a pine tree that could use a trim?

After all the leaves have fallen from the trees, be sure to have your **gutters cleared**. They are likely filled with dead foliage and twigs, clogging and preventing them from doing their job.

<u>Birds can't rely on worms and fruits</u> in the winter for food. Instead they turn to seeds, and that's something you as their human neighbor can help them stock up on. Make sure to place the bird feeder in a spot that's sheltered from strong winds.

Most plants can weather the colder months just fine, but some need a <u>layer of added protection</u>. Spring-blooming shrubs such as azaleas and rhododendron, fragile blooms including dahlias, and citrus trees are some plants that could use an extra layer in the winter.

<u>Gardeners add mulch</u> in the spring to prevent weeds and lock in moisture, but mulch is also important in the winter. A layer of straw as mulch protects the soil from temperature fluctuations, so that the ground stays frozen—and the plants dormant

December 30, 1803 - The *Stars and Stripes* flag was raised over New Orleans as the United States took formal possession of the territory of Louisiana,



Automatic License Plate Reader Technology Leads to Arrest in Shooting on Atlantic Avenue

On Nov, 16, 2024 at approximately 1:57 a.m., officers from the Virginia Beach Police Department (VBPD) responded to the 1100 block of Atlantic Ave. for a shooting.

Officers arrived on scene and found an adult male suffering from a gunshot wound. The victim was later transported to a local hospital in stable condition.

Thanks to automatic license plate reader cameras, video footage and eyewitness statements, investigators identified Timothy Kashner (M/35) of Suffolk as the suspect. On Nov. 20, 2024, Kashner was arrested and charged with Malicious Wounding, Use of a Firearm in Commission of a Felony, Shooting in Commission of a Felony, and Possession of a Firearm by a Convicted Felon.

"Cameras help solve crimes," said VBPD Chief Paul Neudigate. "Whether it be security cameras or automatic license plate readers, technology plays an invaluable role in our continuing mission to protect and serve our community."

Camera Technology Helps VBPD Thwart Attempted Firearms Theft

On Dec. 14, 2024, at 1:16 a.m., a local firearms dealer contacted Virginia Beach Emergency Citizens and Communications Services (ECCS) to report a burglary in progress at his business.

Officers from the Virginia Beach Police Department (VBPD) responded to the scene at the 900 block of Reon Dr. They located a 16-year-old male from Chesapeake inside the business. The juvenile was taken into custody and charged with Burglary of a Business, 23 Counts of Attempted Larceny of a Firearm, Possession of Burglarious Tools, Possession of a Firearm by a Minor, and Destruction of Property.

"We are incredibly thankful the owner implemented surveillance cameras in his business. As a result, he was able to discover the crime in progress and quickly alert law enforcement. Our officers were able to immediately respond and arrest the subject. In doing so, they prevented 23 firearms that the subject was trying to abscond with from falling into the hands of those that cannot legally possess them or would use them in the furtherance of other criminal activity." said Police Chief Paul Neudigate. "Cameras and an involved citizen played a direct role in denying criminals the means to commit future acts of violence in our city or elsewhere."

VBPD invites residents and business owners to register and/or integrate their security cameras with the department's Keep Virginia Beach Safe initiative. Visit the program's webpage to learn more.
